SAMPLE BEQUEST LANGUAGE

A gift to Holy Trinity Catholic Church in your will or revocable trust proclaims your confidence that we will continue to fulfill our mission and make a difference in the lives of future generations. A bequest:

- Is easy to arrange.
- Will not alter your current lifestyle in any way.
- Can be easily modified to address your changing needs.

RESIDUAL BEQUEST: A residual bequest comes to us after your estate expenses and specific bequests are paid:

I give and devise to Holy Trinity Catholic Church, located in Colorado Springs, Colorado, all (or state a percentage) of the rest, residue and remainder of my estate, both real and personal, to be used for its unrestricted use (or for the support of the Holy Trinity Parish Endowment Fund).

SPECIFIC BEQUEST: Naming Holy Trinity Catholic Church as a beneficiary of a specific amount from your estate is easy:

I give and devise to Holy Trinity Catholic Church, located in Colorado Springs, Colorado, the sum of \$_____ to be used for its unrestricted use (or for the support of the Holy Trinity Parish Endowment Fund).

CONTINGENT BEQUEST: Holy Trinity Catholic Church can be named as a contingent beneficiary in your will or personal trust if one or more of your specific bequests cannot be fulfilled:

If (insert name) is not living at the time of my demise, I give and devise to Holy Trinity Catholic Church, the sum of \$_____ (or all or a percentage of the residue of my estate) to be used for its unrestricted use (or for the support of the Holy Trinity Parish Endowment Fund).

RETIREMENT PLAN: You may name Holy Trinity Catholic Church as a beneficiary of your IRA or other qualified retirement benefits. To make a charitable gift from your retirement plan, <u>simply enter the Holy Trinity Catholic Church name and Federal Tax ID #84-0486943 on the Change of Beneficiary Form, available from your plan administrator. Consult with your advisor to determine the benefits you would derive from such a gift.</u>
